The funds will be used to educate the residents of South Carolina with a special emphasis on the underserved and limited-resource clientele about the four major health issues affecting the citizens in SC State PSA's service delivery area.

1. Diabetes - South Carolina had the 8th highest prevalence of diabetes among adults in the nation in 2018. One in seven adults has diabetes, or approximately 500,000 adults in South Carolina.
2. Heart Disease - South Carolina is ranked 10th in the nation in deaths and it's the leading cause of death in our state. Heart disease accounted for 55,853 hospitalizations in South Carolina during 2019, with total hospitalizations charges of that \$4.5 billion. Ten thousand five hundred seventy-eight (10,578) people died from heart disease.
3. The adult obesity rate in South Carolina is 32.3 percent, 12th highest, according to the 14th annual State of Obesity Better Policies for a Healthier America report from the Trust for America's Health (TFAH) and Robert Wood Johnson Foundation.
4. One in twenty adults experience serious mental illness each year, in South Carolina, 183,000 adults have a serious mental illness. Twelve-seventeen have depression. One in six US youth aged 6-17 experience a mental health disorder each year.
