Please explain how these funds will be used to provide a public benefit:

Provide animals with a safe, clean, secure and healthy enviroment for the stray animals of our community that end up homeless, abandoned and unwanted. Keeping animals safe during inclement weather. Improve the life of animals in our care with manners training, more comfortable bedding, outdoor activities, and better spaces. Provide a surgial suite to have a vey come weekly for spray/nueter, eliminating the morning delivering and afternoon pick ups of 2 or 3 animals a day from verteriantian offices. Provide indoor/outdoor runs with with properly grated flooring to allow proper drainage from either side. Helping to reduce the spread of diseases to other animals and humans. Strong fencing with the topleaning inward to allow play time during nice weather, sanitizing runs, or as needed without worring about that climbing dogs getting out.

1. Would a new shelter enable us to have healthier animals?

Yes. Currently our dogs are in chain link cages, outside, sharing a common chain link fence "wall". They are able to share diseases as when they defecate there are no barriers, and it seems their favorite spot is in the corner of the "shared wall". The dogs are always rubbing against the chain link "wall" to scratch, giving the neighboring dog access to body parts to bite. Ears, lips and tails are often chewed creating the need for a vet visit to stitch up wounds that have to be treated with antibiotics for several days. We can judge success with fewer sick animals, fewer vet bills, quicker adoptions and rescues. We would measure this with our Animal Shelter Program and The County Treasurers report of vet bills. When the animals go out quicker and the vet bills are reduced we will show success.

2. Would a new shelter reduce drainage issues?

YES. Currently our drainage system dates back many decades. With just a regular summer shower, our drainage system backs up into one section of the shelter, creating flooding issues for our puppies, mamas with babies,

We would be successful when we no longer had flooding issues.

3. Would a new shelter create a safer work environment for staff?

YES. Currently mice are eating through the walls of our office, leaving mouse droppings on everything in the office, (creating health issues for staff) the drainage issue creates disease that is transmittable to humans, termites are eating everything wooden, there are leaks in the buildings creating floor rotting. We would measure success when we have no issues with mice, drainage, termites or leaks.
